Our Company in the course of its business activity requests, obtains and processes personal data under different titles from different natural persons. Our Company pays attention to manage the least personal data possible for carrying out its activity, with following the principle of data sparing. We acknowledge and observe those rights of natural persons that are ensured by the legislation concerning their personal data and the protection of their data.

We inform you that there is no data protection officer working at our Company.

The following rights stipulated by the law are due to you in respect of the protection of your personal data.

- a) Right to appropriate and comprehensive information
- b) Right to access your own data
- c) Right to correcting and supplementing the inaccurate and deficient data
- d) Right to deletion (being forgotten) along certain regulated conditions
- e) Right to withdraw you consent
- f) Right to request restricted data processing
- g) Right to object against data processing
- h) Right to not be the subject of automated decision making if requested, and to request human intervention by applying in the course of decision making
- i) Right to the portability of the data, in cases that are defined by law
- j) Right to submit a complaint to the "Supervisory Authority"
- k) Right to court remedy against any data controllers and any data processors

In the case of each of these rights, you have the right to present requests in connection with it, and we will answer to your request without any unjustified delay, but at least within 25 days, and in extremely complicated cases we will meet your request within two months. We will deliver to you the answer electronically, or in any other manner you request.

If you think that in spite of the provisions of the governing legislation we acted unfairly or unlawfully in respect of you, you may present your complaint to the data protection Supervisory Authority. In this case you may turn to the following Authority with your complaint:
